GENERAL

The contract, properly executed by exhibitor, shall upon written acceptance and notification of exhibiting arrangement assigned by conference management, constitute a valid and binding contract. E-Learning Council reserves the exclusive and total right to control all aspects of the conduct of this event; and specifically, it reserves the right to determine the eligibility of any exhibitor for inclusion as a conference exhibitor. Requests as an exhibitor for this symposium may be refused or restricted due to space limitation or other reasons as determined by E-Learning Council. E-Learning Council also reserves the right to render all interpretations and decisions, should questions arise, and to establish further regulations as may be deemed necessary to the general success and well-being of the exhibitor and the symposium. Symposium management's decisions and interpretations shall be accepted as final in all cases. E-Learning Council will have sole control over all admissions of persons to the symposium. The acceptance of this contract does not carry nor imply endorsement of the product or service by E-Learning Council or its affiliated organizations. E-Learning Council reserves the right to restrict any exhibit or sponsorship because of noise, method of operation, or any behavior that is judged dangerous or objectionable; and also to prohibit, or to evict, that which is considered to detract from the general character of the symposium, exhibit area and/or exhibitors as a whole. This general restriction includes persons, things, conduct, printed matter, or anything deemed objectionable by E-Learning Council. In the event of such restriction or eviction, E-Learning Council and its affiliated organizations is not liable for any refund or other exhibitor expenses. Exhibitor agrees to conform to all rules and regulations stated here and below. Exhibitor agrees not to "sell" its products or services in the main ballroom. Breaches or infractions of these rules may ieopardize the right to exhibit at future conferences hosted by E-Learning Council.

EXHIBITOR PAYMENT

Payment to secure an exhibitor space must be received with this form submission; otherwise the exhibiting space may be released to the next exhibitor. Visa, MasterCard and American Express will be accepted, and charged by MicroAssist, Inc.'s credit card processing system. No exhibit space assignment or exhibitor arrangements will be made prior to payment of exhibitor fees. Exhibitors with a balance due will not be allowed on the exhibit floor or at the symposium until the balance is paid in full.

CANCELLATION/REFUND

Cancellations must be submitted in writing. Cancellations are effective on the date written notification is received by E-Learning Council. A fifty percent (50%) refund will be given for cancellations received on or before April 5, 2015. Exhibitors cancelling after April 5, 2015, will be responsible for payment in full, and may jeopardize the right to exhibit at future conferences.

ASSIGNMENT OF SPACE

Exhibitor spaces are awarded on a first-come, first-serve basis; based on the date the contract is received by E-Learning Council, date of full payment received by E-Learning Council, and the availability of requested exhibitor space. E-Learning Council reserves the right to assign exhibitor spaces based on other equitable considerations. E-Learning Council also reserves the right to reassign and/or extend exhibitor selections and quantities, as it may deem necessary and equitable.

LIABILITIES

The exhibitor, by signing this contract, agrees to hold harmless and indemnify E-Learning Council, MicroAssist, Inc., the venue, the E-Learning Symposium sponsors and their respective employees, representatives, agents, successors and assigns, for any and all damages to its property that exhibitors may suffer during installation or removal of an exhibit or before, during and after the symposium or exhibit itself, including liabilities from robbery, fire, accident, or any other destructive cause and for all injuries to any persons, resulting from its exhibiting and exhibiting at this symposium. Exhibitor will be held responsible for any damage done to the building by it, its employees, its agents or its independent contractors.
